- 1) Personal account deposit is used for initial uniform issues, clothing replacements, journey expenses, pocket money etc. for which a statement of account is sent at the end of every term and the deposit to be paid along **with the 1st term / at the time of admission.**
- *2) The school fee is likely to be increased by 7.5% year on year.
- 3) **Parent's attention is drawn to the following School Rules:**
 - a) **The due date for 1st term fee is payable at the time of admission and 2nd term fee is payable by 30th June 2025.** Parents are requested to pay the fees before the due date. No reminder for School fees will be issued to parents.
 - b) If the fees and other dues are not paid by above stipulated date, penal charges of Rs 5000/- will be charged per week's delay for a maximum of four weeks. If the fees is not paid within one month from the due date with penal charges, the parent will be asked to withdraw the child(ren) or alternatively the name of the child(ren) will be struck off from the School rolls and the child(ren) will be sent back home.
 - c) **Withdrawal:** Once admission is granted, the fee paid will not be refunded if the parent decides not to continue the education of his/her child in the School.
 - d) In case a child is to be withdrawn from the School, prior notice must be given in writing to the Headmaster. If such notice of withdrawal is given by **31st December 2024** and the child is withdrawn by **31st March 2025** (before commencement of new academic session), no fees will be charged for the next academic year. **In case the child is withdrawn from 01st April 2025 to 30th June 2025, the first term's fees of the year will be charged. For withdrawals made from 1st July onwards will have to pay the full second term fees.**
 - e) There is no concept of proportionate fees or proportionate late payment penalty charges.
